City Manager Irvin, Finance Director King, Fleet Supervisor Teferi, Street Supervisor White, Parks Supervisor Tammons, and City Clerk Jones were in attendance.

The following is a summary of the discussion during the budget workshop:

- Gasoline 4-year comparisons report explained. Compared station bought gas to in-house bought gas.
- Pool house is still being repaired.
- In-house asphalt & concrete repairs are saving funds.
- Duties of street department.
- Limp pickup after the heavy storms.
- Seasonal employees will help keep grass cutting current.
- Research pretreating dumb trucks and proper wash stations.
- Pool schedule 11am-6pm Tuesday-Sunday.
- Vehicles in need of some major repairs.
- 2 seasonal positions in parks will be replaced with 1 full time employee. Salary adjustments.
- All Parks employees are asked to receive a Class-B driver’s license.
- Sprinkler system will be installed at City Hall and Fire House 1. Low water source has to be resolved.
- Budget has to reflect full funding of grants.
- Complete First-aid kits will be added to the Pool House and Lake House. Defibrillators need to be added.
- New tables and chairs for Civic Center. Some park benches will be replaced.

Streets Supervisor White excused at 2:03pm.
 Parks Supervisor Tammons excused at 2:48pm.

Councilman Hindeleh moved, Councilwoman-at-Large Greene seconded, and the motion carried to hold a budget meeting on 05-21-19 at 1pm.
