Memorandum of Understanding  
By and Between  
Geraldine Minor Goston and The City of Berkeley

This agreement entered into by and between Geraldine Minor Goston, hereafter referred as the "Instructor," and the City of Berkeley, hereafter referred to as the "City," outlining the roles and responsibilities of both parties in the 2019 Summer Low-Moderate Impact Water Aerobics.

## A. Mission Statement

The mission of the City of Berkeley Parks and Recreation Department is to help our families with fitness and nutrition. We hope to build a healthier Berkeley constituency.

## B. General Duties and Responsibilities:

1. Family Pool Fitness Program - \$ 600.00 - Berkeley
2. Pool - including noodles – Berkeley
3. All classes will be in the shallow end of the pool
4. Instructor will provide classes each Saturday morning at 8:30am
5. Beginning June 1, 2019 – August 31, 2019
6. Facility Location - Berkeley Pool
7. Workout Times – 8:30am – 9:30am
8. Parks & Rec will Create and Distribute Sign Up Flyers
9. Instructor will Provide Liability Waivers for participants - Submit A Copy to Berkeley
10. Participation Cost is - \$ 10/ Person for the entire summer (June-August) - Berkeley will Collect Payment
11. Music – Instructor will Provide Music Equipment
12. Families - are responsible for bringing their own water shoes, towels, etc.

## C. Desired Outcomes

- Introducing Physical Fitness in the water
- Weight Loss/Body Toning
- Getting Families Excited about Working Out Together

## E. Evaluation of the Program

After the conclusion of the summer program, both Geraldine Minor Goston and the City of Berkeley Parks and Rec. Department will sit down to evaluate the overall effectiveness of the program.

F. Funding Agreement

The City of Berkeley will pay the instructor at the end of each month \$200.00, through the end of the summer session.

H. Terms of Agreement

This agreement will be enforced for the length of the program during the summer of 2019. Any revisions or modifications to this agreement, mutually agreeable to both parties, will be documented in an addendum and signed by Geraldine Minor Goston and the Berkeley City Manager. Either party, upon written notice to the individuals the agreement to their successor if applicable, may terminate this agreement. Said termination shall take effect 48 hours upon receipt of written notice.
