Mayor Hoskins called the special meeting to order and requested the reading of the notice at 11:10 am.

City Manager Irvin, Fire Chief Linhardt, Interim Police Chief Jackson, ED Coordinator Smith-Drake and City Clerk Jones were in attendance. Anthony Thompson, CEO of Kwame Building Group was a speaking guest with the approval of the council from the 10-21-19 council meeting.

SFS Architecture did not show for their appointed time of 10:30am. Hastings + Chivetta gave a presentation at 11:15am. Arch Images gave a presentation at 12:30 pm. Each company spoke about their business and how they could fulfill the project requirements, with time for questions and answers. Each had concerns for the site location due to being in a 100 year flood plain. Both stated the city will need to have a flood study performed. MSD must approve the site before building. A site “B” must be considered.

Roll Call: Mayor-Aye, Hoskins-Absent, Mitchell-Aye, Williams-Aye, Greene-Aye, Hindeleh-Aye and Anthony-Aye (Aye-6) motion passed.

Councilman Hindeleh moved and Councilwoman Anthony seconded the motion to hold a special meeting on 10-29-19 at 1pm to select an Architect from today’s presenters only. Roll Call: Mayor-Aye, Hoskins-Absent, Mitchell-Aye, Williams-Aye, Greene-Aye, Hindeleh-Aye and Anthony-Aye (Aye-6) motion passed.

Councilman Hindeleh moved, Councilwoman Anthony seconded, and the motion carried to adjourn the meeting at 1:41 pm.
