**AN ORDINANCE OF THE CITY OF BERKELEY, MISSOURI, AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH SPENCER CONTRACTING FOR PAVING OF CERTAIN STREETS ACCORDING TO BID #909**
