**AN ORDINANCE OF THE CITY OF BERKELEY, MISSOURI, REPEALING
ORDINANCE 4467 NAMING 8098 ZOE DRIVE TO WILLIAMS POCKET PARK**

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BERKELEY,
MISSOURI, AS FOLLOWS:**

Section 1. Ordinance 4467 “Naming 8098 Zoe Drive to Williams Pocket Park”, received final passage by the Council on May 21, 2018, is hereby repealed.

Section 2. The City shall erect signage, in appropriate locations, reflecting a name once the Council approves a name for the Pocket Park.

Section 3. This Ordinance shall be in full force and effect from and after its passage.

AN ORDINANCE FOR THE CITY OF BERKELEY MISSOURI NAMING 8098 ZOE DRIVE TO WILLIAMS POCKET PARK

WHEREAS, 8098 Zoe Drive was acquired in 2014 by the City of Berkeley as vacant land; and was zoned Park Land on April 17, 2018 under Ordinance #4451; and

WHEREAS, the City Council, in recognition and honor is desirous of naming 8098 Zoe to Williams Pocket Park; and

WHEREAS, the City Council will work to have a monument installed at this park dedicating it to Brenda Williams, Councilwoman Ward II, for her dedication in creating this Park for the residents of Ward Two. Councilwoman serves faithfully on the Betterment Commission beautifying the city for over seventeen years.

Now, Therefore, Be it ordained by the City Council of the City of Berkeley, Missouri, as follows:

Section 1. The City shall erect signage, in appropriate locations, reflecting the name and existence of the William Pocket Park, and may otherwise refer to the Park as such. All references to this park (or as a defined term as "Park") in City ordinances, resolutions, grants, and other laws of the City are hereby amended to reflect the said renaming to Williams Pocket Park, see **EXHIBIT A**.

Section 2. This Ordinance shall be in full force and effect from and after its passage.
